**IN ADDITION, DUE TO COVID-19 ELECTORS ARE ENCOURAGED TO BRING THEIR NOMINATION FORMS FILLED OUT TO THE NOMINATION MEETING AND THEN LEAVE THE NOMINATION MEETING ONCE THEIR NOMINATION IS RECORDED.**

**Mail-in ballots will ONLY be sent to those voters who request them directly from the address below; they are NOT automatically mailed to voters who receive this Notice as per the FNEA Regulations.**
